The comic show may be an on-going monthly series.

A/C unit in Master Control - Barker Mechanical inspected and wants to replace the room unit - waiting on quote. We continue to monitor temp with fingers crossed.

We received the MOU from the Marin IJ. CMCM will trade production assistance for their public affairs program in exchange for bi-weekly print advertising and web advertisement. Will probably begin production in October in the new studio.

Received an initial quote for master control upgrade - 285K, gulp! Will be working with Media Control Systems on modifications to their proposal but we may eventually come close to that amount. Fortunately we're in good shape on other capital plan equipment purchases and this shouldn't create difficulty.

Filed ex-parte comment with FCC on DN 14-261, about 160 filings total with around 40 coming from access centers.

#### **Gov Advisory Council**
