Way back when we first opened we did two back to back Democracy Now shows and a three hour live Presidential Debate from the JCC. We didn't screw that up so it was inevitable they would return someday - and appropriately enough, on Community Media Day. These are always a chance for staff to get experience in the chaotic and hellish world of live news production, always good experience, though I expect we'll all be dragging by tomorrow night.

We start rewiring the audio system in Mill Valley, actually just replacing everything. Basically, some past upgrades had resulted in difficulties and we needed to empty conduits of the original wiring that had been cut off and simply start over. We'll be upgrading the video in November - if things stay on track.

Novato is prepping for their new installation in November/Dec - an 8 week install period apparently. That's good, as their 8 yr old system is dying rapidly - this week one of the UPS units died during a meeting and brought down half the control room. We didn't bid on their chamber work, it is far too over designed and unnecessary for what they actually need - and we weren't interested in replicating an expensive mistake. Plus, our priorities are with MTA members and that keeps us busy enough.
