I've been too busy this week to really process the full consequences but will have to move on options next week. We also have or bi-annual audit this year making this even more untimely fun.

• Web developments. Our web host is planning to upgrade PHP which will disable our current Drupal 6 installation They will carry us as long as possible in our current version. Meanwhile, staff will be reviewing some cloud based media center management tools I've scheduled starting next week. One of these would replace the specialized modules we currently use with Drupal.

### Government Updates

• Did a training with MCE on their new system so they can use it for staff meetings between locations. They still have audio hiccups to work out.

• Met with San Rafael twice, our install is hung up by other renovations so dates are still uncertain. Fairfax may get moved ahead of them should the delay continue.

• Meeting with Fairfax staff in a couple weeks too to work out installation details/changes. I also met with their clerk this week on closed captioning issues which are looming.

• Still awaiting word from Tiburon on whether they want to move forward - but it doesn't seem likely at this point.

• Trained new Mill Valley operator - so far no issues reported.

• Sausalito had their vBrick encoder die before the last meeting, swapped out a replacement and all appears fine. These encoders will be replaced as we roll cities over to HD, most were used when we purchased them and many have been in operation for six or more years.

Novato's 200K system continues to have glitches and the installers are MIA to address

problems. MTA cities should feel lucky.
